# ECONOMIC

The welfare of the animals under our care is of utmost importance. Case Farms, alongside our contract growers, share a committed responsibility to ensure the well-being and humane handling of all animals in our care. As a leading-poultry producer, we appreciate our consumers' concerns and want to ensure the public that Case Farms is fully committed to the health and well-being of the poultry we manage.

We believe that healthy animals lead to healthy people and a healthy planet. All Case Farms chickens are raised cagefree and are fed a carefully balanced corn and soy based diet, formulated by a professional poultry nutritionist, with no added hormones, steroids or growth-promoting antibiotics. We do not use antibiotics important to human medicine on a routine basis; rather, they are used only for treatment when needed under the direct supervision of and prescribed by a licensed veterinarian. We also provide vigorous routine oversight and relentlessly pursue continuous improvements in bird health and environmental conditions.




Land, water and energy are all important to ensure we minimize the impact on the environment. Whenever possible, we source corn, soybeans and other feedstuffs locally to support the economy where we operate, and to minimize the use of fossil fuels. We constantly strive to minimize our water usage through conservation practices in our processing plants and the use of modern drinking systems for the chickens on the farms. Additionally, we have water reuse and state of the art wastewater facilities where we treat the water used in our processes before we discharge the water to local streams and local municipalities. We also evaluate and utilize methods to safeguard our energy supply, such as the use of modern LED lighting.

## History


Thomas R. Shelton always dreamed of owning his own company. In December 1986, after gaining almost two decades of management experience in the poultry industry, Shelton purchased a small family-owned poultry operation in Ohio. The company was called Case Egg & Poultry, and included a processing plant in Winesburg, a hatchery in Strasburg, and a food distribution facility in Akron.

Shelton changed the name of the company to Case Farms. In its first year of operation, Case Farms had 140 team members, processed 135,000 chickens per week, and produced 22 million pounds of poultry products.



In May 1988, Shelton purchased the Morganton, North Carolina poultry operations formerly known as Breeden Poultry & Egg. This operation included a processing plant, hatchery, and a feed mill. In August 1998, Case Farms purchased the Goldsboro, North Carolina poultry operations (processing plant, hatchery, feed mill and grain storage facility) from WLR Foods. In 2012, the Company made its latest acquisition – a Canton, Ohio facility from Parks Farms. The operations included a processing plant, cooler/freezer facility, and a hatchery.

Over the years, Case Farms continued to expand its facilities and offerings in North Carolina and Ohio. Today, the Company processes 3.3 million birds per week, and produces in excess of 1.0 billion pounds of fresh, partially-cooked, and frozen-for-export poultry products per year.



#### Safety Program

Case Farms' safety vision is guided by our "Road Map for Safety Success." This is a plan of action that defines the direction of the safety program, sets measurable goals for the year and tracks the Company's progress against those goals.

We have implemented many practices which can only be considered state of the art. Case Farms strives to create a work culture and environment where our employees feel valued and safe.

Following are a few examples of initiatives and practices currently in place:

Corporate safety structure and procedures, including training methods for our employees.

Utilization of ProcessMAP's integrated health and safety software to aid in reporting within OSHA's workplace safety standards. Weekly safety team meetings

Deployment of Alchemy software for safety training in many areas throughout our plants and necessary documentation for OSHA on all employee training. This helps us standardize our training company-wide, and ensures we are covering the necessary safety topics for all new hires. Weekly top management review of each OSHA recordable injury or illness.

Weekly employee round table discussions to raise and address all employee issues and safety concerns.

In addition, we regularly evaluate our corporate safety structure and procedures, compliance reporting and training methods, and conduct safety audits of all facilities and make improvements when and where needed.

Our dedication has not gone unnoticed. The industry has acknowledged our dedication and successes in our safety program. In the past five years we have received more than a dozen safety awards from notable organizations including the American Meat Institute and US Poultry & Egg Association.

Numerous times over the years, Case Farms has achieved significant safety milestones. In many of our Ohio and North Carolina facilities, we worked more than a million consecutives hours without experiencing an Occupational Safety and Health Administration (OSHA) recordable lost time accident (LTA). In 2017, the Goldsboro processing facility achieved 2 million hours worked without a LTA, and in 2018, reached the 3 million hours worked milestone.

It is our mission to keep worker safety our highest priority. Our goal in this ongoing process is to ensure that our Company becomes an industry leader in worker safety.

#### Community Involvement

Case Farms is grateful to have hard-working, dedicated and loyal team members as the backbone of the Company.


Our team members come from diverse backgrounds and experiences, working together to satisfy our customers' needs with the best and most consistent quality chicken.

For many farmers, the ability to obtain poultry houses has taken idle land unsuited for other farming and made it a valuable cash flow producing asset. These poultry houses help farmers maintain the farming way of life, as they increase the family income from the existing land and provide sources of new income into the farming economy.



#### Food Safety

Case Farms maintains a culture focused on accountability and commitment to product safety. We have programs in place to ensure the safety of our product from development all the way to the end consumer.

We employ team members who are subject matter experts and nationally-certified in food safety through the National Registry and Serv-Safe. These members of management are individually and/or collectively members of State and National committees focused on food safety and sit on organizational and academic advisory boards.
